Alabama PSC Call Data Report Information and Instructions

The initial report due in 2016 consists of monthly calls, minutes of use, and revenue for calendar years 2013-2015. The report due in 2017 (2016 Call Data Report) and each year thereafter includes monthly data for the previous calendar year.

For the initial report, there are three Excel workbooks, one for each of the calendar years from 2013-2015.

At the bottom each workbook, are separate worksheets for each calendar month in the reporting period.

Enter the calling data in the worksheet corresponding to the applicable month.

Prison and jail data must be submitted separately. The provider that serves DOC facilities in Alabama will submit one report for prisons and a separate report for the jails they serve. Providers that serve only county and/or municipal jails in Alabama will only submit one report.

For each facility served, the report data consists of the site ID, Facility Name, then cells to enter the Call Count, Bill Minutes, and Call Revenue for <u>revenue producing calls</u> ONLY. Non-revenue producing calls shall be excluded.

There are separate sections for each call type: Collect, Single Payment Calls, Prepaid, Debit, Debit Card, and Direct-Billed Collect. Shown below are only 3 of the call types.
